3. Foreword by the Chief Executive Officer of Dublin and Dun Laoghaire ETB

This Annual Report for 2015 reflects a bedding down of reforms which took place during the previous 18 month period. There has been an ongoing commitment across the ETB to building an identity for the new Education and Training Board. The three counties of Fingal, South Dublin and Dun Laoghaire Rathdown which we serve continue to experience population growth. We have expanded schools and other services where resources permit to accommodate growth. There are still many challenges to be faced to provide an appropriate level of service.

Further Education and Training has adapted very well to the new approach to planning and reporting. This has had implications for how Training Centres, Post Leaving Certificate Colleges and Adult Education Services work together. There has been great progress towards aligning the services and more will be done in the years ahead.

In schools there has been another exceptional year of growth with new schools ensuring a high quality education for the students whose parents have entrusted to us. Collaborative networks in Teaching and



Learning, Special Needs, Language & Literacy, Information and Communications Technology have all helped to develop interactive approaches to the central purpose of classroom teaching and learning.

There is no doubt that a lot has been achieved already in creating the new organisation. There is still a lot to be done together to continue to consolidate and improve over the coming years.

It has been a privilege for me to work with my colleagues among the staff over the past year. I am particularly grateful for the support of the board who have shown such an interest and commitment to their duties.

4. Organisation Services

The modernisation and upgrading of systems within the ETB's Organisation Services continued in 2015. Despite the Public Sector moratorium on Recruitment continuing throughout 2015, good progress was made with a programme of improvements. Included in the modernisation programme was implementing new e-business solutions and upgrading existing systems after a review of existing processes. The ETB remains committed to the continuous improvement of its services in the context of the Government's Transformation of Public Services Programme.

5. Financial Summary

Dublin and Dun Laoghaire ETB is funded primarily by the Department of Education and Skills (DES) for the delivery of its second level and SOLAS and DES for further education and training programmes. In 2015, funding for particular projects was also provided by other Government Departments and Agencies including:

- Department of Community, Equality and Gaeltacht Affairs
- Department of Social and Family Affairs
- o Office of the Minister for Children and Youth Affairs
- o Department of Enterprise, Trade and Innovation
- European Union.

Funds are also raised through charges for services such as tuition fees, rent of rooms and activities at local level. The Board's receipts for 2015 were €199,560,705. Dublin and Dun Laoghaire ETB is audited annually by the Comptroller and Auditor General (C&AG) who presents a report on the Board's financial stewardship to the Oireachtas. Of the total receipts last year, €20,076,116 was in respect of the Capital programme.



6. Key relationships

One of Dublin and Dun Laoghaire ETB's strategic priorities is to work in partnership with the major stakeholders in its three counties of Fingal, South Dublin and Dun Laoghaire/Rathdown. To this end, the ETB collaborates with a range of public bodies and providers of training and education. For example, Dublin and Dun Laoghaire ETB is a member of the Local Community Development Committees (LCDC) of the County Councils of Fingal, South Dublin and Dun Laoghaire/Rathdown. The ETB works closely with the local Partnership companies as well as having representation on the Governing Bodies of the Institute of Technology Tallaght and Blanchardstown Institute of Technology and the Institute of Art, Design and Technology in Dun Laoghaire.

In 2015, Dublin and Dun Laoghaire ETB co-operated with a large number of other organisations and institutions through the provision of teaching hours or financial assistance, such as:

7. Schools

Introduction

The number of pupils in our Schools and Colleges continued to grow during the 2015 school year, at second level and PLC. In September 2015 Kishoge Community College moved out of its temporary accommodation and into its new state of the art building in Adamstown. 2015 saw the sanction to open a new school in the Kingswood area of Tallaght awarded to DDLETB. The recruitment of the Principal took place and the exciting process of setting up the new school was started.

A large number of subject inspections took place again in 2015 all of which can be accessed on the website of the Department of Education and Skills (DES) on www.education.ie. There was excellent practice observed in reports with enthusiastic teaching and very effective team teaching practices in place. Management support and meticulous planning were reported with teachers being especially commended for their extensive support for a wide range of co-curricular and extracurricular activities to support their subject. Peer-assessment and self-evaluation encouraged amongst students was noted along with subject planning using state examination information. The development and implementation of homework



strategy was recommended. While the communication between staff was highly commended in some inspection reports it was recommended to be expanded in others.

Three Management Leadership and Learning (MLL) inspections took place – in Deansrath Community College, Balbriggan Community College and Adamstown Community College. These Inspection reports found clear vision and strong commitment from both staff and Boards of Management. Along with the implementation of new initiatives and a positive atmosphere the quality of teaching was found to be very good with exemplary SEN provision noted.

Programmes being offered in our community colleges include -



Goals	Sample of Actions from 2015
1	QQI Level 2 <i>Skills for Life</i> : Provided framework & accreditation for students with mild / moderate general learning disabilities which compliments mainstream curriculum including new junior cycle. 7 schools delivered the programme with 4 schools submitting students for certification.
2	iTunes U: iTunes U courses were created which adhere to a pathway of learning as set out by the curriculum. These Innovative & exciting courses redefine and modify the student experience. Students were provided with digital literacy skills for life.
3	TL21 (Teaching and Learning): Principals and Deputy Principals promoted TL21 as a form of Continuious Professional Development (CPD) in their schools. The TL21 Programme is a workshop-based Continuing Professional Development programme for teachers and school leaders that promotes innovative practice and professional learning communities in post-primary schools. Following on from the TL21 training 105 teachers received certs and 12 schools received "Centre of Innovative learning" recognition.
	Continuous Professional Development : A one day in-service session was delivered to train, support and develop guidance counsellors and another for Special Education Needs (SEN) coordinators. A half day workshop was also delivered to develop the competence of relevant teachers in testing students using standardised assessment tools e.g. CAT
4	Language Literacy and Numeracy (LLN): Provision of LLN awareness-raising sessions to schools was made available on request. Bespoke literacy & numeracy workshops for schools for their subject teachers were delivered. CPD workshops were provided to individual schools. All serving teachers had access to CPD and guidance on meeting the learning needs of EAL students as per the National Strategy for Literacy and Numeracy. It was ensured that all teachers delivering EAL support continued to be qualified as per DDLETB EAL guidelines.
	Leaving Certificate Applied (LCA): As one of three leaving certificate options the LCA offers students Leaving Certificate subjects with a strong practical and vocational emphasis. Aimed at preparing students for adult and working life the LCA programme enables students to identify and explore their own talents while enhancing their personal development. At the Annual LCA Showcase in 2015 10 schools showcased 30 students' projects which ranged from Hairdressing and Catering to Woodwork and Recycling. The projects created quite a buzz in Head office for staff and students from visiting schools being given enthusiastic explanations from the students taking part on their chosen subjects.
5	EAL (English as an Alternative Language): The EAL initiative continued to meet all the QA requirements for Cambridge English exams linking with all of the Second Level Support and Development team to provide additional educational resources for pupils whose first language may not be English.



8. Further Education and Training

Introduction

The merger in 2013 of County Dublin VEC, Dún Laoghaire VEC and three former FÁS Training Centres into a single entity, Dublin and Dún Laoghaire Education and Training Board (DDLETB), lead to the formation of a large Further Education and Training (FET) sector within DDLETB.

At the same time SOLAS, the new Further Education and Training Authority, became responsible for the strategic co-ordination and funding of the FET sector nationally.

Scope of FET Provision in DDLETB

DDLETB FET provision offers full and part-time courses in a wide range of fields to a large and diverse population of post second level learners. Programmes include Apprenticeship, Blended Learning, Bridging/Foundation Courses, Community Training Centre provision, Justice Workshops, Local Training Initiatives, PLC, Specialist Training, Specific Skills Training, Traineeship Training, VTOS, Youthreach, Adult Literacy, BTEI, Community Education, ESOL, Evening Training, FET Cooperation Hours, ITABE and Skills for Work.

* 'Beneficiaries' refers to the total numbers of learners participating in courses between January 1st and December 31st of any given year. Totals for learners completing courses and achieving certification include learners who finish their course during that year. Outputs for learners enrolled in courses that run over an academic year are counted in the following year.

** Estimated expenditure

The table provides a breakdown of learner/beneficiary numbers and grant requested for 2015. Estimated number of completers and certification rates for full-time, part-time and unaccredited provision are also presented.

Funding values do not include the full cost of PLC provision. DES funds PLC places directly. The funding values in the table are inclusive of allowances in lieu of income support for learners who qualify for DSP allowances.

DDLETB' Strategic Goals and Implementation Plan 2015-2020

Following the reforms to FET, and in response to the national SOLAS strategy for FET, DDLETB identified six high level goals which it aims to achieve during the period 2015-2020 (DDLETB FET Strategic Goals 2015-2020). They are:

- 1. Skills for the Economy
- 2. Active Inclusion
- 3. Quality Provision
- 4. Integrated Planning and Funding
- 5. Standing of FET
- 6. Integrated FET Services

An implementation plan was developed which sets out the objectives and the actions to be completed to achieve the goals. (Appendix C: DDLETB Strategic Goals for FET 2015-2020: Implementation Plan). Progress is recorded periodically and a report is presented to DDLETB's senior management team annually for review.



Progress towards FET Strategic Goals and Objectives in 2015

DDLETB achieved significant progress in implementing its FET strategic goals and objectives in 2015. Table 2 contains some examples of actions completed in 2015.

9. Youth and Sports Development Service

Introduction

DDLETB Youth and Sports Development Service aims to provide a wide range of supports that enable the delivery and co-ordination of high quality educational, sporting, recreational and developmental programmes, projects and services to disadvantaged young people. This is done in partnership with local communities, voluntary groups and voluntary youth organisations such as Crosscare, Foróige and YMCA. The Youth and Sports Development Service also provides a number of directly managed targeted programmes.

Scope

Programmes were delivered in line with the five National Outcomes of Better Outcomes Brighter Future (The National Policy Framework for children and young people 2014-2020)

- Active and Healthy, physical and mental wellbeing
- Achieving full potential in all areas of learning and development
- Safe and protected from harm
- Economic security and opportunity
- Connected and Respected and contributing to their world

Sample Actions

Some examples of the many and varied activities included:

- Youth Cafés
- Youth Clubs
- Youth Information
- Summer Projects
- Computer Clubhouse
- Outdoor Pursuits

Some examples of DDLETB directly managed targeted programmes included:

- Active Youth Challenge
 - The Active Youth Challenge asks youth clubs/groups/schools to meet a set of standards of 12 hours of physical activities in 12 weeks to be eligible for the DDLETB Active Youth Challenge Award. Activities and attendance for each activity session must be recorded by Activity Coordinators in the logbook provided.
- Sportivate (in conjunction with South Dublin County Council)
 This programme caters for participants primarily between the ages of 18 and 25 who are interested in breaking into the sports industry in some capacity or furthering their educational opportunities.
 Participants undertake a programme of education which includes Sports and Recreation Studies FETAC Level 4.



- Alternative Learning Programme
 - The ALP is an interim educational programme for young people aged between 12 and 16 years who have encountered difficulties in coping with mainstream education and consequently are not currently attending school on a regular basis.
- Dual Purpose Sports Halls— Phibblestown, Killinarden, Firhouse, Collinstown, Palmerston The Dual Purpose Sports Centre Programme aims to open these state of the art facilities to both partner second level schools, local National Schools, Community and Youth Services.
- Sailing (in conjunction with Baltinglass Outdoor Education Centre)
 Based in the Marine Activity Centre in Dun Laoghaire harbour, the sailing programme provides beginner and intermediate sessions for youth groups, summer projects and schools.

Sample Achievements

- Over 3,500 volunteers and over 45,000 young people involved with the service in 2015.
- 510 Youth Clubs and 113 Youth Projects.
- 19 Young people participated in the inaugural year of the Sportivate programme completing a programme of education which included Sports and Recreation Studies QQI Level 4.
- Active Youth Challenge delivered to over 750 Young people across 7 schools and 36 youth groups.

10. Psychological Support Service

Introduction

The Psychological Support Service (PSS) is available to students in Second Level Schools, Youthreach Centres, and sectors of Further Education within Dublin and Dun Laoghaire Education and Training Board (DDLETB). A broad range of psychological supports is provided in response to requests submitted by schools/centres. The PSS also offers short term support to staff working within DDLETB. At a systemic level, the PSS engages in research, training and ETB initiatives.

Scope

Service is provided by the PSS according to the resources available. Interventions by the team are directed towards:

- the provision of both direct and indirect support to students
- the resolution of behavioural, motivational, emotional and cognitive difficulties of individuals, through assessment and therapeutic intervention
- preventative work with target groups
- professional support of teaching staff, e.g. consultation
- in-service training in a range of areas
- staff support
- the professional placement of Trainee Psychologists



Sample Actions

Approximately 400 staff engaged with the PSS for a range of purposes including consultation, in-service and support. Requests to the PSS regarding approximately 300 students were addressed through individual or group interventions. The work of the PSS also included collaboration with external agencies such as NEPs, City of Dublin ETB, University College Dublin, and further education support services.

Sample Achievements

- Expanded the implementation of Feuerstein's Instrumental Enrichment cognitive enhancement programme
- Delivered Reflective Practice Initiative
- Provided training in assessment for staff
- Supported Guidance Counsellor and Learning Support networks
- Facilitated reading intervention research
