DDLETB had circa €9m on hand at the end of April. The authorised Main Scheme Non-Pay spending ceiling for DDLETB in 2017 has been confirmed at €7.971m, an increase of circa €197k on 2016. An appeal letter was issued to DES requesting an increase in this spending limit for the year but no response has been received to date. The current shortfall on Non Main Scheme is not a real deficit, it is an accounting issue which will be regularised in the short term. The majority of the Non-Main Scheme receipts have been recorded under Training Centres until SOLAS provide sufficient details to facilitate the correct recording of same. There no other significant issues to report.

Balbriggan Community College – New Building

Work on stage 2A is progressing with planned meeting with Department provisionally programmed for late June.

An application for additional funding has been submitted to the Department and a response is awaited.

Mount Seskin - SNU

A response to our application for additional funding, is still awaited.

Scoil Chormac CNS (Permanent Building)

The issue with the electricity supply, which had delayed the project, is now resolved and the school will be ready for occupation for the new academic year

Benincasa Special School

Planning documents are being prepared with a view to submission to DLRCC by mid-May. The Dominican sisters have approved the latest floor plans, site plan and line boundary. Detailed design is progressing.

7.4. CEO's Report

CPD/School reports – the CEO reported that since the last ETB meeting on the 20th March, there has been significant work done in relation to teacher collaboration through the Middle Leadership Programme, TL21 initiative, the TEL Connect sessions, DEIS planning, LLN, SEN, Deputy Principals and Principals networks as well as other CPD events. There have also been a number of inspections at subject level and school level.

Co-operating with County Councils – the CEO and Senior Management of DDLETB attended bilateral meetings with the South Dublin County Council and Fingal County Council relating to shared concerns. For example in relation to Adamstown Community College we have been asked to estimate the costs of running the community element of the hall and meeting rooms out of school time.

New Deputy Principal Positions - Interviews and appointments took place in relation to 15 additional Deputy Principal positions in schools.

Teaching posts - Teacher posts are being advertised on an ongoing basis from now on so there will no closing date.

News & Events - Fingal Community College held its Student Enterprise Awards. The CAST Film Festival took place in the Lighthouse Cinema in Smithfield. The event is run by teachers in Collinstown Park CC and had 2100 entrants this year with 300 invited to the festival night.

Co-operation with IADT - Two more FE colleges signed Memorandums of Understanding with IADT. They were Sallynoggin College of Further Education and Stillorgan College of Further Education joining Dun Laoghaire Further Education Institute and Blackrock Further Education Institute ensuring that there is a progression pathway from as many courses in those colleges to IADT as possible.

Community National Schools - An event to explain the reconfiguration process for Primary Schools took place in the DES on Friday 12th May. This process is about surveying in areas that have indicated there is a need to transfer school patronage. A consultative process will follow to decide on the transfer.
