3. Community National Schools Presentation from Mr Séamus Conboy, ETBI

Mr. Séamus Conboy, recently appointed by ETBI as national coordinator for Community National Schools, presented on the current CNS model of which six of the schools will shortly come under the patronage of DDLETB. He highlighted the non-denominational ethos of the schools and demonstrated how, in this context, they operate very successfully. Members noted how well placed the schools are in the context of the Catholic Archdiocese's programme for divestment of primary schools.

DDLETB had circa €10.1m on hand at the end of August. The Main Scheme Non-Pay cash deficit accumulating since 2013 has not been addressed by DES in the year to date and there is currently no proposal to resolve this issue. On 27th July, DES formally sanctioned an increase in the Non-Pay spending threshold to €7.8m. While this does not bridge the cash shortfall, it has allowed DDLETB to provide an increase in Non-Pay

funding for new and growing second level schools in 2016. This is a most welcome departure from DES and it is much more in line with the funding requirements of DDLETB than the previous spending limit of €7.2m set in 2012. As things stand there are no other significant issues to report.

5.1.2. Bank Overdraft Facilities

The possibility of requiring an overdraft facility before the end of the financial year was discussed. Members noted that at present there is no indication of such a facility being required however in the interests of business continuity it would be best to have the necessary approval in place should the need arise.

It was agreed, on the proposal of Cllr. Mick Duff, seconded by Mr. Gerry McGuire, to seek Ministerial approval for an overdraft facility in accordance with section 49 of the ETB Act, 2013.

5.2. Buildings' / Capital Report

The following was noted in respect of the Board's current building/capital programme:

Gaelcholáiste Reachrann

Following a recent stage 2A meeting with the Department, it is expected that the project will be approved for advancement to stage 2B in early October.

Balbriggan Sports Hall/Extension (Devolved Project)

The sports hall is substantially completed. The stage 1 report for the new school building is complete and with the Department for review.

Lucan Community College - Extension

The design team is continuing work on the stage 2A submission with a completion date scheduled for mid-October.

Luttrellstown Community College Phase 2

Stage 2B submission due to Department shortly. Contractor tender documents being prepared

Kingswood Community College

Temporary accommodation is installed and fully operational. Work on the stage 2B submission is continuing.

St. Finian's Community College Extension (Devolved Project)

Tenders for enabling works have issued. The pre-qualification process for a main contractor is underway and the stage 2B report is expected to be submitted to the Department by mid-October.

Lusk Community College - Phase 2

The stage 2B report is under review by the Department.

Coláiste Chillian (ADAPT)

Work on the stage 2A submission is continuing.

5.4. CE's Report

The Chief Executive reported as follows:

Schools and centres are reporting that results in the state examinations and QQI awards are in line with expectations. A number of principals have said that they were particularly pleased with students whose expectations entering courses were more modest than what they achieved.

Community National Schools- Citywest and Saggart CNS has had its patronage transferred to the ETB. The schools will complete the vetting process prior to transfer. All schools to complete the transfer by 1st October.

Junior Cycle - The current IR dispute is affecting DDLETB's dual Union schools which include 13 designated community colleges and three non-designated with a large proportion of ASTI members. The most recent development is the announcement of the agreement between the Department of Education and Skills and the INTO and TUI unions on pay restoration for new teachers. This further amplifies the gap in pay between unions in favour of the Lansdowne Road agreement and those against.

ETBI Conference - The conference will take place this week in Killarney. The theme chosen is "Equity in Education." One session will look at the interventions that makes a difference. Another looks at mental health and well-being. Other sessions deal with the Teaching Council's fitness to practice procedures, entrepreneurship, reflections on Padraig Pearse and the Irish school system. The Minister will address the conference.

Scoil Aoife – The new building has been handed over for use by the school. Ms Stacey MacAuley, Principal, is delighted with this beautiful building and landscaping job.

TEL Conference - There was a special conference in the training centre Tallaght for DDLETB FET staff nationally including guests from other ETBs last Wednesday. It was a very successful conference well organised by the development officers and the IT Department from Head Office along with the Training Centre staff in Tallaght. Visiting speakers from Denmark and England made for a strong line up added to by practitioners from services across FET in DDLETB. Special thanks to Dr Fionnuala Anderson who made the links and was inspired to hold the conference as well as getting involved in every area of planning for the event. Great innovations in teaching as a result of the conference are expected.

The Inspectorate has reviewed and re-published the Looking at Our Schools document as a guide to schools in looking at self-evaluation. It is a very useful document and would be of benefit to members of Boards of Management. There are Statements of Effective Practice and of Highly Effective Practice to which schools may aspire in the document.

Kingswood Community College the 32nd post-primary school for DDLETB opened to students in late August with 51 students. Already 120 students have enrolled for 2017. The school is housed in pre-fabs until the new building is completed.

CNS - Members requested a further presentation of the "Goodness Me, Goodness You" programme provided in the Community National Schools. Mr Séamus Conboy, ETBI, to be requested to attend the Boards October meeting.
