DDLETB had circa ≤ 12.5 m on hand at the end of February. The authorised Main Scheme Non-Pay spending ceiling for DDLETB in 2017 has been confirmed at ≤ 7.971 m, an increase of circa ≤ 197 k on 2016. Notwithstanding that, DES will provide only ≤ 7.223 m in actual cash for the year. Unless additional cash is provided in the course of the year, this will result in an increase in the cumulative deficit on the programme. The current shortfall on Non Main Scheme is because the underlying receipts have been recorded under Training Centres in the short term until SOLAS provide sufficient details to facilitate the correct recording of same. There are no other significant issues to report.

4.2. Buildings' / Capital Report

Report on Capital/Building Programme

Gaelcholáiste Reachrann

Stage 2A has been approved by the Department and the design team is now preparing stage2B. It is expected that a planning application will be lodged by early April.

Balbriggan Community College – New Building

Work on stage 2A is progressing.

Lucan CC – Extension

The stage 2A report was recently approved by the Department. The design team will now prepare the stage 2B report which includes the lodging of a planning application and securing of fire and DAC certificates.

Luttrellstown Community College Phase 2

Stage 2B is with the Department. The project will now be part of a "rapid build" bundle of second level schools, currently being progressed by the Department.

Kingswood Community College

The pre-qualification process for contractors continues, with a closing date of 12th April.

St. Finian's Community College Extension (Devolved Project)

The due diligence process on the contractor selected for the enabling works is not yet finalised.

Lusk Community College – Phase 2

A prequalification process for building contractors is underway, due for completion shortly.

4.4. CEO's Report

Griffeen Community College – The CEO informed the Board that Griffeen Community College iss the name for the new ETB School in Lucan in partnership with Scoil Sinead Ltd. The school is due to be a 1000 pupil, second-level, coeducational school and will be open to all in the catchment area defined in the patronage campaign. The school is due to open in September under Ms Rachel McGrath who is taking up duty on 21st March 2017. Meetings with Scoil Sinead have been ongoing over the past few months and the Principal is working on policies and procedures as well as making practical arrangements for the operation of the school. The model agreement with Scoil Sinead was finally agreed on 20th March. The interim board of management will be in place after 20th March to assist the Principal in managing these early days. The school will be initially accommodated in Kishoge Community College and will move to a site acquired near Lucan East Educate Together Primary School. The new Principal has excellent experience as Deputy Principal in Kildare Town Community School.

Psychological Support Services presented to the senior management team on a proposal to expand psychological support services to deal with additional students. Their proposal will be put into the business case and presented to the Department in the near future.

St Oliver's Training Centre is in use again. There was an initiative called Crossbars which had a visit from the Minister Frances Fitzgerald on 3rd March. The training course was in cycle maintenance and the crossbar initiative was to train eight Traveller man in cycle maintenance and repair to City & Guilds standard. They become part of a very small group of trained cycle mechanics in Ireland.

Balbriggan Adult Education Service held an awards ceremony on 16th February. The largest number of level five graduates ever to obtain full awards were presented with a certificate at that night. It was also a night to remember as the Adult Education Officer in Fingal, Austin Wynne, announced his summer retirement. The CEO thanked Austin and all the team for their excellent work over the years developing the service in the Fingal area.

The Community Training Centres had their 40th Anniversary in Dublin Castle on 6th March at which the Minister attended. It was great to celebrate this very important event for the Community Training Centres of which DLLETB is proud to have three; Blanchardstown, Ronanstown and Dun Laoghaire.
