4.1 Finance

4.2 Staff:

Appointments/Promotions/Resignations/Career Breaks/Jobsharing/Pro Rata Contracts

Issues relating to the commencement of section 30 of the Teaching Council Act on 1st November, in the context of the specialisms required in PLC colleges, were discussed. The CEO advised that a circular letter, which will provide some relief in this regard, is expected shortly.

4.3 Building Programme

The following was noted on the Board's current building programme:

Donabate Community College – All Weather Pitch

Following a meeting with Fingal County Council the specialist consultant engaged to review the drainage design intent of the project, has been requested to report on the optimum level for the possible reinstatement of the pitch. The adjacent library site, for possible use as a temporary recreation area for students, is no longer required.

Gaelcholáiste Reachrann

A response is awaited from the Department on the revised cost reconciliation.

Balbriggan Sports Hall/Extension (Devolved Projects)

A proposal for a full decanting of the College to temporary accommodation on the site, during construction of the permanent building, is currently under consideration. A meeting with the Department is expected shortly.

Lucan Community College - Extension

The issue relating to additional fees for the design team has been satisfactorily resolved. A value engineering report on the possible separation of the refurbishment of the existing building and the extension, is currently being drafted.

Castleknock Sports Hall & Classrooms

The Department has approved the project for tender and it is expected that an RFT (request for tender) will issue to the pre-qualified contractors by early/mid November.

Luttrellstown Community College - Phase 2

The stage 1 submission is currently being completed by the design team. The proposed development of an all-weather pitch with a local club is being deferred. The Department is concerned, arising from difficulties with local residents on planning for stage 1, that a planning application for an all-weather pitch, in advance of an application for the school building, may give rise to significant delays with the phase 2 project.

Kishoge Community College (Devolved Project)

Tender documents have issued to the prequalified contractors with a closing date of 12th November. An unexpected issue regarding drainage of a section of the site has arisen. A meeting with South Dublin County Council planners is being arranged.

Ardgillan – Permanent Extension

Work on phase 1 of the extension is progressing. Priority rooms for early completion are currently being identified with the Principal.

St. Finian's Community College Extension (Devolved Project)

Following discussions with planners in Fingal County Council a variation order, for rezoning of the lands to the north of the school for education use and which are in the ownership of the Board, is being processed.

Lusk Community College – Phase 2

Issues on the stage 2a submission, as identified by the Department, are currently being addressed by the design team.

Citywest

Tenders for the "risk management" works are currently being accessed.

Citywest – Scoil Niamh

A road opening licence, to facilitate site entrance works, is expected this week.

Temporary Accommodation – 2014

Applications for additional accommodation for Gaelcholáiste Reachrann, Scoil Niamh and Educate Together national schools, Citywest, are being prepared.

Senior College, Blackrock Completion of the building is expected for late January.

Dún Laoghaire Further Education College

An emergency works application for conveying structural works has been submitted to the Department.

4.4 Miscellaneous:

FÁS/SOLAS

Members noted that SOLAS will be established on the 27th October and Ms Cecilia Munro, Principal, Dún Laoghaire Further Education Institute, has been appointed to its Board. FÁS has written to all staff in this regard. I.R. discussions are ongoing at national level. A meeting was held today with FÁS personnel to facilitate business planning.

Section 29 – Training

Training for Board members and Principals was held today.

Korean Project

Members were informed of a project on Transition Year with an Education Authority in Korea. The Korean Authority is seeking to introduce a transition year programme and in this regard Marie Griffin, Education Officer, recently presented a paper in Seoul. DDLETB will be working with the Authority and a reciprocal visit is scheduled for 28th October.

School App – St Finian's Community College

Details of an app. developed by St. Finian's Community College and which was recently launched by the Minister for Education and Skills, were outlined. The Minister has expressed a wish that the app. be made available to all second level schools. In this regard DDLETB has linked with a company to assist the roll out of the app. across the Board's schools initially.

ETB Aggregation

Members noted that the relocation of staff from the former headquarters of Dún Laoghaire VEC to Tuansgate was completed on the 30th September.
