1. Following the Strategic Dialogue meeting with SOLAS at the end of May, 2022, FET has recently agreed its contribution to the national targets in priority areas, including Supporting Jobs, Creating Pathways, Fostering Inclusion, Upskilling through Lifetimes and Careers, Targeting Critical Skills Needs. The new targets will be implemented across FET along with actions to help achieve targets between 2023 and 2024.

#### FET Response to Ukrainian Refugee Crisis

2. The Adult Education Services (AES) across the county continue to manage the initial response to the Ukrainian Refugee Crisis and have provided information sessions with translators in hotels, rest centres, community centres and libraries as required. As the main reception centres for refugees are in Citywest and the Red Cow Hotel which are both located in the South Dublin County area while Fingal particularly the Swords area is also welcoming large numbers of refugees.

This has put a lot of pressure on FET staff and resources for example the Adult Education Service in Tallaght has recruited an additional 18 English language tutors and is in the process of recruiting more to meet the demand.

#### **Capital Bids-FET DDLETB**

3. Earlier this month, Minister Simon Harris launched the Strategic Infrastructure Upgrade Fund in Clondalkin and announced the DDLETB bid for the refurbishment of a FET building on a site in Monastery Road, Clondalkin Village had been successful. The second application for an upgrade of FET facilities in Tallaght Training Centre has also been successful and both projects are now at decision gate 1. The outcome of two bids for major capital investment will be announced in November.

#### Visit of EU Commissioner -Youthreach Swords

Elisa Ferreira, EU Commissioner for Cohesion and Reform, is due to visit Youthreach Swords this week. Youthreach has been prioritized for the visit due to its amazing work with young people and progression to work, further education, apprenticeships or higher education.

# Ukrainian learners participating in FET

As of the 1<sup>st</sup> September, there are 756 beneficiaries on FET programmes who have a nationality of Ukrainian. 96% of those are in the Adult Education Services and 77% are female- youngest 18, oldest 83 years of age.

practical approaches for learning and teaching as well as caring for ourselves and our learners. Participants are provided with a certificate of attendance for the programme.

For 2022/2023, priorities for the DDLETB development support team with schools will focus on a whole school values led year of embedding Ethos - namely Care, Community, Equality, Excellence in Education and Respect. The purpose of which is to

- Raise awareness and embed our ethos and core values
- Enhance inclusive practice in schools
- Improve outcomes for all learners
- Build communities of practice and support best practice in learning and teaching

**DDLETB Leadership Connect Programme** will commence at the end of September. The aim is to promote professional development in the area of educational leadership within our organisation. This is split into

- Teaching Leadership Programme (TLP) for non-positional teachers. This year's programme will see a new cohort of non-positional teachers gain experience in educational leadership as well as be supported to bring about positive school developments through team TLP projects. Last year saw 143 graduates of the TLP across 28 P and PP schools take part.
- Middle leadership programme (MLP) for middle leaders. This programme is designed to enhance and develop the skills of middle leaders/post holders in our schools and centres. This is the second year of the new re-developed programme which is a yearlong certified programme. Last year saw 56 participants graduate from the programme.

A specific **Induction Programme for new CNS Primary teachers** nationwide will focus on – living the ethos and values in addition to initial delivery of the Patron's Programme, Goodness Me Goodness you (GMGY). One training session took place on 13<sup>th</sup> September on Ethos. The remaining sessions will commence on 22<sup>nd</sup> September, 4th and 22<sup>nd</sup> October 2022.

**SEN** development and support worked with the **NCSE** in delivering a pilot programme aimed at supporting schools in implementing a whole-wide positive behaviour strategy across CNS. Engagement was positive and schools completed the programme resulting in their own bespoke toolkit supporting their priorities in enhancing behavioural strategies in their school.

Directors of Schools continue to facilitate communities of Practice among all our schools with DDLETB support officers in areas of SEN, DEIS and Leadership (TLP) with these programmes developing responsively to the needs of the schools over the coming year.

#### **Dual Purpose Sport Centres**

The Youth and Sport Development Service manages six Dual Purpose Sport Centres across the South Dublin County Council and Fingal County Council Administrative Areas (Firhouse, Palmerston, Collinstown, Killinarden, Phibblestown and Balbriggan). There was a recorded footfall across all the centres of 246,432 in 2021.

A sensory audit and training for all staff within the 6 Sport Centres has been completed with Aslam. DDLETB Sport Facilities are now accredited as Autism -Friendly Community facilities, contributing to the inclusive culture within our centres and acknowledgement of DDLETBs ongoing commitment to diversity and inclusion.

#### **Summer Provision**

A variety of activities were offered to target young people in the DDLETB area between June and August of 2022. This included:

- Summer sports workshops were provided by youth sports officers. This included young people from Foroige Youth Services (Whitechurch, Tallaght, Blanchardstown) Crosscare Youth Services (Clondalkin, Ronanstown, Dundrum /Rathdown) MCA, Clondalkin Travellers Youth Service,
- Summer Sailing: 87 sessions were provided to targeted young people. These sessions were organised by Sports Officers in partnership with Baltinglass Outdoor Education Centre. Sailing sessions took place on Blessington Lakes
- Palmerstown Summer Camps: Sports Officers supported DDLETB summer camps for young people in Palmerstown
