5 Matters Submitted by the Executive

5.1 Reports from Chief Executive

Chief Executive and Director reports circulated in Board pack and verbally presented to the Board.

- Board Members were reminded that the FET requirement was originally costed closer to €100m, specifically €99.8m. The current budget is €93.4m therefore there is a gap; the majority of which is in relation to Apprenticeships (allowances and course delivery). DDLETB is continuing engagement with SOLAS and the National Apprenticeship Office (NAO) in relation to funding. The Board Members expressed their support in relation to FET funding and noted its importance.
- DLR Board Members expressed their disappointment that DL and/or Dún Laoghaire did not feature in the new FET College branding but acknowledged the process. FET video to be circulated to all members.
